The events of Tuesday night's (9/14) board meeting continue to haunt me as an American citizen. I have been a law-abiding citizen my entire life. I will not be complicit in Tuesday night's events.

All seven elected trustees are equals. The law does not allow any trustee to have any power as an individual trustee. Only as a body do we possess or exercise any power. The law is clear on that. Board officers do not enjoy any additional lawfu powers than non-officer trustees.

Board President Amy Weir does not have law enforcement authority. She does not have the authority to determine whether a crime is being committed. She does not have the authority to direct a law enforcement officer to take any action under the authority he possesses as a LEO. <u>LEO's alone are</u>

<u>charged with making decisions on enforcing the law</u>. The only civilians empowered to direct law enforcement to do anything are <u>judges</u>. Even then, they cannot direct when, how or where their orders (such as an arrest warrant) will be executed.

If Amy Weir directs a LEO to "remove' a citizen from a meeting, physically prevent a citizen from entering our meeting or any other order, then I as a peer of hers, can just as easily direct the LEO to NOT "remove" a citizen. We are equals. <u>Only if a LEO himself believes he is witnessing a CRIME occur can he take appropriate action to enforce the law.</u> Not Amy Weir.

Good LEO's do not take orders on how to enforce the law from trustees. They do not bend to the orders of civilians.


<u>The courts have ruled that a LEO placing his hands on a citizen have arrested that citizen</u>. All arrests must generate an arrest report. LEO's know this. Since 1 Aug 2021, citizens have been forcibly removed from RRISD board meetings and on Tuesday night, RRISD PD LEO's put their hands on more than one citizen in preventing them from entering the board meeting.

<u>I am hereby requesting a copy of all arrest reports from the RRISD PD documenting the arrests of</u> <u>citizens in RRISD board meetings from 1 Aug 2021 through 15 Sep 2021. Dr Azaiez- Please provide</u> <u>these reports to all trustees before the next board meeting which will be Saturday at 8:30 am.</u> We need to see these reports. And we need to see if the reports reflect that the officers were taking orders from Amy Weir.

If arrest reports were not written, then we have an <u>even bigger problem</u>. If that's the case, we may have 1983 Civil Rights violations.

I believe that Amy Weir is blinded by political doctrine that has rendered her unable to operate within the confines of the law.

I have real concerns about the 14 Sep 2021 Regular Board Meeting. <u>One of those concerns is about the</u> <u>agenda and the public being denied the opportunity to speak on item J1 (Mask Matrix).</u>

I have watched the board meeting on-line twice now and this is what happened:

25:15 mark - Item D1 (public comments of agenda items E, F, G, H) appears to end
28:00 mark - Board Pres Weir announces both "adjourn" and "recess" with no notice of when to reconvene
30:40 - VP Feller motions to approve G1-5 (via consent passes 5-0) <u>successful business conducted</u>
33:40 - VP Feller motions to approve G6 (tax rate passes 4-1) <u>successful business conducted</u>
48:30 - We appear to be back to DI (public comments of agenda items E, F, G, H)
50:10 - Sec Harrison motions to nominate Mason Moses to WCAD board (passes 4-1) <u>successful business conducted</u>
51:50 - Weir "suggests that we postpone everything else in this meeting until Saturday"
"Everything else" appears to be Items I1 (public comments on agenda item J1) and J1 (Mask Matrix).

No vote or consideration of removing these items is discussed or voted on. 52:10 - Weir calls board into closed session and <u>board successfully deliberates Items K1 & K2</u>

Why does the RRISD website currently state: Update: Due to public disruption at the September 14, 2021 regular meeting, item J on the <u>September 14 agenda</u> will be discussed at a future Board meeting.

This is a lie. There was no public disruption that prevented the board from addressing item J1 (mask matrix) as demonstrated by the board successfully accomplishing many other agenda items, passing a tax rate, taking action coming out of closed session, appointing a WCAD director, etc. <u>Please remove this language from the RRISD website.</u>

In addition, on 13 Sep 2021, I sent an email to Pres Weir and Dr Azaiez asking that Item J1 be removed from the 14 Sep 2021 agenda. <u>Pres Weir replied, "This is a matter for the full Board to discuss</u> tomorrow and it (J1 Mask Matrix) will not and cannot be removed from the agenda at this point in time with less than 72 hours before the meeting." This email exchange is subject to the PIA.

<u>Please explain why you (Weir) unilaterally (with no vote by the board) removed items 11 and J1 from</u> <u>last night's agenda.</u> Many parents showed up to speak on this J1 "Mask Matrix" and were left denied with their time wasted. How are you allowed to unilaterally deny them the opportunity to speak on an <u>item listed on the agenda?</u> Your own words to me in writing on 13 Sep 2021 clearly state that the J1 Mask Matrix WILL NOT AND CANNOT be removed from the agenda.

These questions have got to be answered to the board and the public before any future meeting on J1 can be held.

Principals and Superintendents,

My original opt out form I submitted will continue to stay in effect, and

will not be wearing a mask in school. Please inform all of their teachers that they will not be wearing masks. I cannot afford to spend \$200+ and time off of work for doctors appointments to receive the medical exemption you believe I need to have, and we will not participate in school board decisions that subvert the law.

In accordance with County Judge Bill Gravel and County Attorney Dee Hobbs's public statements (see link below for County Attorney mask mandate clarification), mask mandates in Williamson County are unlawful in our public schools. The Texas Supreme Court has not made a ruling on the Governor's ban on mask mandates. The Clark family will continue to follow GA-38, which has the full effect of law.

Lastly, I expect that will not be coerced to wear a mask, segregated, ostracized, or discriminated against in any way.

Pres Weir,

Moments ago the TX Supreme Court stayed both the Dallas and Bexar County Judge's mask mandates. These were the first two county judges to issue such mandates so they were the first ones that the Texas Attorney General brought to the Texas Supreme Court.

Their stay order today is signaling where they are headed with their ruling. I just got off the phone with the TXAG's office who advised me that they will be bringing the Harris, Travis and other county judge mask mandates to the Texas Supreme Court in short order.

I see that there is a called board meeting to discuss COVID protocols on Monday 8/16/21. I'm making an assumption here, but I am guessing that it relates to making a decision on mandatory masking.

I'd like to remind you all that the board voted 5-2 to dismiss our Level III complaint, denying us due process, and citing that what we were requesting was outside the authority of the board due to Governor Abbott's Executive Order GA-36.

In addition, on August 3rd, 2021, the Superintendent designee, on behalf of the Board of Trustees sent us the attached Level III dismissal letter stating, "Governor Abbott's Executive Order No. GA-36 provides "school districts cannot require any person to wear a face covering after June 4, 2021. The Executive Order remains in effect indefinitely." At the end of this letter of dismissal, it also states "In accordance with Board Policy FNG(LOCAL) this decision shall be final action on the grievance by the District."

By your own admission in this document, you do not have the authority to make a decision that violates Governor Abbott's Executive Order GA-36. I hope that you will keep this in mind when discussing this decision on Monday.

Mr Clark, Thank you for sharing these screenshots as I stopped following Vessa's page long ago for my own sanity. I asked Vessa back in AprMay/Jun to stop with the dysfunctional posts and rmails. You can request those emails via the PIA.

The words in these screenshots are troubling and destructive. In addition, I was notified via email by Dr Azaiez this morning that the TXAG contacted RRISD last night regarding the boards unlawful 5-2 mask mandate vote earlier this week. I asked him to let the TXAG know by 5 pm today that Trustee Bone and I dissented because we want to distance ourselves from unlawful votes and acts. If RRISD does not fulfill my request, Bone and I will have no choice but to notify the TXAG of this ourselves in writing. I recommend all persons who are aware of policy violations to file grievances with RRISD and TEA. Illegal masking violations should be reported to the TXAG and TEA.

As I said in the board meeting on Monday night, our community deserves so much better. I will share that trustee Bone and I had the opportunity to tour 4 elementary schools this morning and I'm currently enjoying the company of MANY fellow parents in our school district at a local establishment. We are all very happy that our children returned to school today and look look forward to a great school year.

Thank you for bringing this to my attention.

Dr Azaiez,

I can't hide my dissatisfaction with your words to Ms Slape. Students on our campuses are not spaced 3 ft apart in their classrooms, the hallways, the lunchroom or on the practice fields. Have you been to a high school football game? It's been a glorious sight to see the second structure living their lives again. The sight has almost moved me to tears multiple times this fall. Our five county area is in Phase 3 (YELLOW) and on the cusp of Phase 2 (BLUE).

Why are you doubling down on restricting the number of seats in the boardroom? There were 100+ seats available in the room in June. Is someone telling you to do this? You are limiting the number of citizens who can enter the board room? Is there any other scenario or situation in which folks are turned away from RRISD classrooms, meetings, etc to enforce a 3 ft distance?

There are no seating restrictions in the other local government meetings such as the commissioners court and city council meetings. Why are you doing this? Why are our meetings different? If this facility will not allow full access, please utilize another RRISD facility that will as you did on 22 Sep 2022 when the meeting was held at the McNiel PAC. We also have PAC's at CRHS and SPHS.

I am all for a large overflow room for folks who wish to distance themselves from others to be able to do so. But TOMA is clear about "complete access." If you utilize the police force to prohibit citizens from entering the board room as happened in the 14 Sep 2021 meeting, thus doubling down on what happened that problematic night, in my view the only thing you will have accomplished is to further inflame the community I have been part of for over a decade. I believe it's time to turn the temperature down in RRISD, not up.

Dear Ms. Slape,

We have increased the number of chairs for the community to 50 inside the Lecture Hall, with those chairs spaced approximately three feet apart. Regarding the posted capacity of 375, we know that number is not possible with the current setup of the room (the dais at the top of the lecture hall and audience setting on the large, flat portion of the hall.) Because that sign predates any current administration and because it seems like an extremely large crowd for the size of the room, the district recently brought in the fire marshall to assess. Indeed, 375 is too large a capacity for the room, even when arranged for the maximum capacity of chairs (something not possible with the dais set up for board business.) We are requesting new guidance on maximum capacity related to different room setups. We are maintaining the three feet of distance right now because that is in line with current health guidance, particularly because not all of our attendees wear masks. Once we reach capacity, we will ask anyone present to watch the live stream from the overflow area. Round Rock ISD Police will maintain order. Because Round Rock ISD Board of Trustee meetings are held on a campus, we ask attendees to arrive no earlier than 4:15 p.m. In-person speaker sign up will begin at 4:30 p.m. I hope this information is helpful.

By complete access, I am referring to community members having the opportunity to attend the entire meeting, in person, within the 4 walls of the Lecture Hall. Will community members be allowed to bring their own folding chairs for additional seating in the Lecture Hall if there is not enough seating provided by RRISD?

Will there be an overflow room for attendees who prefer to socially distance?

Will the answers to these questions (in the form of a RRISD Policy) be posted publicly prior to and at the Board of Trustees Meeting?

Thank you for taking the time to answer these questions. I trust that all answers will comply with the Texas Open Meetings Act and the Texas Education Code.

Mr Clark,

Over the weekend I sent an email to the board president and superintendent (Per board policy) and requested the following agenda item for our next meeting:

"Discussion and possible action regarding the seating logistics in our board meetings."

The board president replied to me that such an agenda item was solely at the discretion of the administration and denied my request. I replied that a board member can put anything he or she wishes on the agenda (as confirmed by a TXAG opinion that was delivered to the board months ago) and that we can vote on anything that is put forward in a motion.

I responded to her denial that I am deeply troubled that the number of seats in our board meetings has been artificially reduced to an extremely low number and does not need the spirit and intent of the Texas Open Meetings Act. I also shared that for the people who are concerned about social distancing, that the common area outside of the board room would be a great place to put up a screen and space seats for those who desire that kind of spacing.

My expectation is that my agenda item request will be respected and put on the agenda. I informed the board president that if the administration could just go ahead and appropriately place plenty of chairs in our board room to allow the members of the public who wish to attend our meetings to do so, that I would withdraw my agenda item request.

I acknowledge that the public is growing more and more concerned and impatient with our boards efforts to silence the community. This is reflected in the removal of most of the seats in our board room. It's also reflected in the boards decision (5-2 vote) to reduce public speaking time from two minutes down to 1 minute in the 24 Aug 2021 board meeting and it is reflected in other ways.

I see that there is a called board meeting to discuss COVID protocols on Monday 8/16/21. I'm making an assumption here, but I am guessing that it relates to making a decision on mandatory masking.

I'd like to remind you all that the board voted 5-2 to dismiss our Level III complaint, denying us due process, and citing that what we were requesting was outside the authority of the board due to Governor Abbott's Executive Order GA-36.

In addition, on August 3rd, 2021, the Superintendent designee, on behalf of the Board of Trustees sent us the attached Level III dismissal letter stating, "Governor Abbott's Executive Order No. GA-36 provides "school districts cannot require any person to wear a face covering after June 4, 2021. The Executive Order remains in effect indefinitely." At the end of this letter of dismissal, it also states "In accordance with Board Policy FNG(LOCAL) this decision shall be final action on the grievance by the District."

By your own admission in this document, you do not have the authority to make a decision that violates Governor Abbott's Executive Order GA-36. I hope that you will keep this in mind when discussing this decision on Monday.

Hello Ms. Sharpe, and Ms. Kim,

Thank you for your responses. This email does not make much sense to me, but I know that you did not write it since I have seen the same email from all of you, so I have cc'd others for awareness.

I intend to exercise my medical and civil rights by choosing to not have a wear a mask at school. We plan to arrive at school with other parents on Friday 4/22/21, 30 minutes after the start of class, so as to not cause a scene on the first day. Virtual learning is NOT an option for and the TEA requires you provide an on-campus education to

After reading the district's email response, I see no authority for RRISD schools to prevent children from attending class without a mask, and I expect that they will not be discriminated against, segregated, or bullied, and will not be encouraged or coerced in any way by students or staff to wear a mask. If this occurs, my efforts will likely escalate to legal action.

1. The first paragraph states that the board approved RRISD's mask requirement, but that is not true. The motion that passed was to continue with the current RRISD COVID Protocol. I have reviewed the first link below called "mask requirement," but that is the link to a protocol document that never once uses the words must, required, or mandatory when referring to masking.

2. The second paragraph is grossly misleading because it says that the district's mask protocol "states" and goes on to quote the first sentence in the protocol document, but the second sentence mixes language that is not in the document with language that is. Protocol documents say what they mean, and mean what they say.

3. In the third paragraph, it mentions that parents "interpreted," not misinterpreted the phrase "should wear masks...." I think most of us parents and all of you are intelligent enough to know that should is not definitive. If I tell she should take an umbrella in case it rains, we both know that the umbrella is not required, but recommended. Telling me and other parents that we have misinterpreted this simple word insults our intelligence. Where this paragraph is accurate, is when it says, "Any student participating in on-campus learning for the duration of the school year must comply with the mask protocols." This is great news to me, because I read the word should for what it is, and will comply with the **recommendation** to wear it IF they want to.

4. The end of this email points to Williamson County and Cities Health Districts and Austin Public Health recommendations. Notice that they are **recommendations**, not mandates. There is no state of Texas mask mandate, and the city of RR mask mandate expires at midnight on Thursday 4/22.

I am taking this stand because the RRISD board has given no indication to an end to their desire to require masking of students, and comments from multiple board members with implications to continue masking for next school year will not be tolerated. The desire to keep children masked flies in the face of all science and trending COVID data. Furthermore, facial recognition and facial que development is most critical to social development and well being from birth to at least 10yrs of age. Lastly, as teen depression and suicide has risen significantly during this pandemic, any continued efforts to cling to a protocol that would keep school age children masked is abhorrent.

As discussed and approved by the Board of Trustees at the Board's regular meeting on April 15, 2021, Round Rock ISD's <u>mask</u> requirement will remain in place for all District schools and facilities through the 2020-2021 Spring semester.

The District's mask protocol states that students, staff members, and visitors should wear masks on buses, other District vehicles, inside school buildings, and anywhere on school grounds. This requirement includes during District events that take place during and outside of school hours. The only exception is that students have the option to remove their masks during outdoor activities, such as P.E. class and recess, providing they can appropriately social distance from others.

The District administration is aware that some families have recently interpreted the phrase "should wear masks" as optional. It is not. This protocol has been an expectation and requirement for the entire school year, and that requirement has not changed. Any student participating in on-campus learning for the duration of the school year must comply with the mask protocols. Students who do not wish to comply may opt for virtual learning.

A complete overview of the District's mask protocols can be found in the <u>Health and Safety Protocols Guide</u>. Round Rock ISD's current <u>COVID-19 mitigation strategies</u> are designed with the guidance of local health agencies. Currently, both <u>Williamson</u> <u>County and Cities Health District</u> and <u>Austin Public Health</u> recommendations regarding masks and social distancing have not changed.

Mr Clark,

I share your concerns. I have personally received two very concerning emails to my trustee email account informing me of these accusations. I received one on 14 Jul 2021 and one on 23 Jul 2021. The first email alleged troubling but not illegal behavior. The second email alleged illegal behavior.

Soon after I received the 23 Jul 2021 email, I sent it to Pres Weir, VP Feller and our board legal council communicating a high level of urgent concern. I insisted on a meeting to be called with our attorney ASAP so that we as a board can seek counsel, discuss concerns and be presented with options for action. Only Pres Weir replied to me and she declined my request. Upon receipt of this, I sent her (and Feller and board counsel) a second request for the same thing urging that we meet sooner rather than later. I have not heard back from any of them after sending that second request late Friday.

I don't know what is true and what isn't but we as a board need to get clarity and a plan. Dr Azaiez is innocent until proven guilty. If these accusations are likely true, then we need to proceed accordingly with legal advice. If these accusations are likely untrue, then we need to proceed accordingly with legal advice. We can only move forward if we meet as a board.

Since I am duty bound to protect **expected** employees, community and the district as a whole, I am growing more and more concerned with each passing day that my urgent request for a meeting is not accepted. I know that Pres Weir traveled this weekend and is not expected home for several more days. But we have a Vice President who can lead our meetings if necessary and only require a quorum to meet and or take action. Given the gravity of the situation, my preference is for all trustees to be present at this meeting.

I'm sorry I don't have a better response to your concerns. Since I have no power an one trustee, I will continue to advocate that the board meet and exercise the leadership and oversight as a body corporate our community deserves.

We have two this week, one on Tuesday and one on Thursday, both at 5:30 pm. "Robust entry plan" are interesting words given what Dr Azaiez gave us. I am happy to share what he gave us (a hard copy booklet) with you at a board meeting. We have two this week, one on Tuesday and one on Thursday, both at 5:30 pm. If you can be there at that time on one of these nights, you are welcome to read through the packet he gave us and return it to Patty Aguilera when you are done. Patty sits off to the side and assists board members with help we need. If you can't make one of this week's meetings, I can leave the packet with Patty at the district office for you to review at your convenience.

One thing I really have to give Dr Azaiez credit for is providing us with a report in this packet that shows that a full 5,000 students that live in the RRISD footprint have opted out of RRISD. His report (pulled from PIEMS, a TEA database) shows which alternatives to RRISD these students have enrolled in. I watched former trustee, Chad Chadwell, ask for this information for years and he was regularly told that it's "too complicated" or "too difficult" to obtain this information by the former superintendent. Hello Board of Trustees,

I am concerned that there have been no open sessions or public forums in regards to the selection of the superintendent lone finalist. I was listening to the called board meeting on 6/3/21, and it was brought to my attention that AISD offered their community multiple opportunities for open forums with their lone finalist.

I'd like to request that the RRISD board of trustees provide at least three open forums for the community to ask questions and address any concerns prior to offering the lone finalist a contract. Please allow us to have a voice. There is no good reason to rush a contract offer before the community has had an opportunity to have concerns addressed. This is a significant hire that equates to a CEO for an organization of over 50,000 people.

Below are some of the concerns about the lone finalist being the best choice for a school district of our size, scope and caliber.

Candidate has less than 3 yrs experience as a superintendent; one of which was COVID year, and the first year of an executive level position isn't typically taken into account because they haven't had time to implement much

Candidate's district (Donna ISD) has no "A" rated schools

Current district has 5 of 21 schools with a failing grade for a 24% failure rate

Current district Academic Growth decreased from a "B" to a "D" under his leadership

Current district (Donna ISD) is less than one third of RRISD (this would be a huge jump in scope of responsibility given the lack of experience and metrics)

Lack of trending performance metrics over time due to short tenure as a superintendent

Lack of success for SPED programs, and has not articulated SPED plans for RRISD

Provided a district entry plan of action just 90 days that lacked substance; a CEO of an organization this size should have a vision for at least a year

Poor school performance record at Spring ISD as area superintendent

Any organization hiring someone at a salary range of ~\$400k should expect an exceptional level of expertise, quality experience, extremely positive performance metrics, and that is not the case here.

Lastly, if the district moves forward with extending a contract to the lone finalist, it should be structured very conservative, with salary incentives based on measurable outcomes.

Good morning,

I appreciate your email. It's important for our parents and community to hold their elected trustees accountable and to ask questions like this.

I personally conducted a lot of research on all four of our finalists candidates. I watched board meetings from their current districts, looked at years of social media posts of their districts and of them personally (if they have an official professional social media account) and I spent a lot of time on the internet looking for media articles on current events in their districts over time. I also reviewed district, campus and student academic performance as reported and publicly available by TEA.

Between the time we narrowed our focus from seven to four candidates, two candidates withdrew from our search. One withdrew because his/her current board of trustees significantly increased his/her annual compensation upon learning of their interest in becoming our next superintendent. The second candidate withdrew to accept another job that he/she applied for three weeks prior to interviewing with us.

That left us with two finalists. After the research I did, Dr Azaiez was not my choice to be the next superintendent and that's why I voted "no".

Here are my reasons:

-Lack of relevant work experience and job performance.

Donna ISD is one of the poorest ISD's in Texas and has a homogeneous student body of 14k. RRISD is one of the wealthiest ISD's in Texas and has a heterogeneous student body of 48k students. I also did not see an established record of improving and sustaining student academic performance. TEA data is nuanced. A grade of "B" in one district doesn't necessarily equate to a "B" in another district. Allowances and adjustments are made in these ratings for things like the % of economically disadvantaged students. Furthermore, the 3 years Dr Azaiez spent as Donna ISD superintendent represents the entirety of his experience as a superintendent. I respect his work in Donna ISD but I do not believe that this enormous jump in size, scope, diversity and needed experience level is in the best interest of a community. I want to add that I have tremendous respect for Dr Azaiez' work in Donna ISD. My "no" vote for him is rooted in my commitment to finding a superintendent I believe is ready to serve in RRISD., right now. That is the standard on which I made my decision. My decision has nothing to do with my opinion on his work in Donna ISD and whether or not I believe he is doing a good job there.

-Concerning media articles I found about incidents and decisions made in Donna ISD during his tenure.

I shared the specifics of these concerns with my colleagues in our deliberations multiple times. One incident involved an SRO accidentally firing his weapon in a high school and the community's concerns about the timeline of their notification of this and the other is about the hiring of a principal in Donna ISD who was filmed on video dragging a student with special needs down a hallway while employed in another district. We asked Dr Azaiez about these incidents and I was not comfortable with the answers/explanations we were given.

If Dr Azaiez does come to RRISD as the next superintendent, I will do everything in my power to help him be successful. I want more than anything for my instincts on this decision to be wrong.

With regard to the other candidate that made our list of final two, I believe he/she had far more relevant professional experience (both in years and in districts more similar to RRISD is size, demographics, etc). Though no candidate is perfect, I believe the selection of the other candidate would have made a lot more sense to our community.

Hello President Weir and Dr. Presley,

There is a very troubling private Facebook (FB) group that has been brought to my attention called "Teachers of Round Rock" (ToRR). There are about 1,200 members in this group, and a number of teachers have made disparaging comments about parents, and gossiping about ongoing trustee legal matters. I have numerous screenshots I can share as evidence. Even more concerning is that trustee Tiffany Harrison is participating in a number of these conversations that bring her ethics as a trustee into question, and she also may have used her position of power to influence the removal of a teacher for having a difference of opinion.

The most egregious comment came from trustee Tiffany Harrison on 3/14/21, when she told teachers in the FB group that she had already made up her mind to vote for continuing student masking at the upcoming board meeting scheduled for 4/15/21, without having heard comments from the public, or debate from her peers during the session. This is unethical appalling behavior by a trustee, and speaks volumes about her disregard for local trending data and thoughts and ideas that are different from her own. Furthermore, it flies contrary to diversity and inclusion by ignoring a marginalized group of parents, by coming to a decision before hearing from that group. This is the very definition of prejudicial oppression, and suppression of freedom of thought and freedom of speech. (screenshot of her comment is attached)

In addition, I have a number of screenshots of disparaging teacher comments and conversations, and a recent screenshot of a comment by trustee Harrison implying that I am a hateful person for a post that I made (using a SHAC board agenda item) to prompt the public to attend the meetings (see attached screenshot). One of the substitute teachers in the group, a friend of mine, took a screenshot of Ms. Harrison's comment, and sent it to me. I sent Trustee Harrison an email informing her that I was aware of her comment, and I asked her to make such comments in public or directly to me instead of to teachers in a private FB group. Approximately two hours after that email, my friend was removed from that Facebook group.

My friend's comment was not inflammatory, so there is reasonable suspicion that she was removed from the group at the request of Trustee Harrison. I cannot prove this, but if she did not make this request using her position of influence, it is quite the coincidence. My friend followed up with the group admin about being removed and was told that it was because she was not a teacher. However, she is a substitute teacher for RRISD and has been a member of

the group for about a year, yet Trustee Harrison is not a teacher and is still a member of the FB group.

The justification given by the admin, the fact that Trustee Harrison is still a member of the group despite not being a teacher, and the timeliness of her removal from the group after the comment leads me to believe that Trustee Harrison was responsible for her removal. This is oppressive behavior that seeks to "cancel" minority views, and is unbecoming of a trustee that is supposed to be a leader and advocate for not just teachers, but parents and students as well.

In the RISD employee handbook, under "Personal Use of Electronic Communications, it states, "As role models for the District's students, employees are responsible for their public conduct even when they are not acting as District employees. Employees will be held to the same professional standards in their public use of electronic communications as they are for any other public conduct." This type of behavior goes against this policy, and is not reflective of a role model for RR district students, and goes against the RRISD professional standards that a teacher is expected to exhibit as a representative of the district.

I can't think of one corporate or government organization that would condone their staff and board members being a part of a FB group that engages in disparaging gossip about their stakeholders (parents), and also uses the platform to silence teachers that do not agree with certain board members positions. I hope you will address this immediately.

I'm asking for four things to rectify this situation:

1. A public apology from Trustee Harrison during the June regular board meeting for both of her actions.

2. Either a formal censure of Trustee Harrison's Facebook voting comments during the June regular board meeting, or that her vote be stricken from the 4/15 agenda item L record.
 3. That the district release an email statement apologizing to parents for the disparaging FB behavior of the teachers.

4. Require teachers and board members to remove themselves from the ToRR FB group, and inform RRISD teachers and trustees that this behavior is not tolerated in this district.

I understand that teachers have a first amendment right in their individual capacity, and that the ToRR group is not an official RRISD page, but condoning an environment where disparaging comments spread like a virus, only serves to foster potential hate, division and biases against our children.

I will be filing a formal complaint on Trustee Harrison's FB voting comment made ahead of the 4/15 meeting. If swift action is not taken with teacher and trustee use of the ToRR FB page, I will consider sharing these screenshots and this story with local media outlets.

If you'd like, I am willing to meet with you both to review the screenshots attached, and others that I have.



I have no intention of changing my mind about showing up tomorrow morning at Forest Creek Elementary with the second seco

When I show up tomorrow, I will request that the principal come to the door to escort into the building. Virtual learning for my second grader is not an option for him, and I would caution against segregating him and others from the other students. If the building based on the current RRISD masking protocol document that does not contain any "must," "mandatory" or "required" language in regards to masking, you will be denying to a Free Appropriate Public Education, and I will pursue legal action.

Please also understand, that this entire interaction will be video recorded, and I will contact Attorney General Paxton, and Williamson County Attorney Dee Hobbs to inform them of this violation if my student is denied entry.

Lastly, over the last couple of days, I have received reports from substitute teachers and parents of students that some teachers are more laxed than others on masks in the classroom, and some are relentless rude, and outright mean to the children, and some with zero tolerance for being able to take a sip of water.

Thank you for your responses. This email does not make much sense to me, but I know that you did not write it since I have seen the same email from all of you, so I have cc'd others for awareness.

After reading the district's email response, I see no authority for RRISD schools to prevent children from attending class without a mask, and I expect that they will not be discriminated against, segregated, or bullied, and will not be encouraged or coerced in any way by students or staff to wear a mask. If this occurs, my efforts will likely escalate to legal action.

1. The first paragraph states that the board approved RRISD's mask requirement, but that is not true. The motion that passed was to continue with the current RRISD COVID Protocol. I have reviewed the first link below called "mask requirement," but that is the link to a protocol document that never once uses the words must, required, or mandatory when referring to masking.

2. The second paragraph is grossly misleading because it says that the district's mask protocol "states" and goes on to quote the first sentence in the protocol document, but the second sentence mixes language that is not in the document with language that is. Protocol documents say what they mean, and mean what they say.

3. In the third paragraph, it mentions that parents "interpreted," not misinterpreted the phrase "should wear masks...." I think most of us parents and all of you are intelligent enough to know that should is not definitive. If I tell the should take an umbrella in case it rains, we both know that the umbrella is not required, but recommended. Telling me and other parents that we have misinterpreted this simple word insults our intelligence. Where this paragraph is accurate, is when it says, "Any student participating in on-campus learning for the duration of the school year must comply with the mask protocols." This is great news to me, because I read the word should for what it is, and will comply with the **recommendation** to wear it IF they want to.

4. The end of this email points to Williamson County and Cities Health Districts and Austin Public Health recommendations. Notice that they are **recommendations**, not mandates. There is no state of Texas mask mandate, and the city of RR mask mandate expires at midnight on Thursday 4/22.

I am taking this stand because the RRISD board has given no indication to an end to their desire to require masking of students, and comments from multiple board members with implications to continue masking for next school year will not be tolerated. The desire to keep children masked flies in the face of all science and trending COVID data. Furthermore, facial recognition and facial que development is most critical to social development and well being from birth to at least 10yrs of age. Lastly, as teen depression and suicide has risen significantly during this pandemic, any continued efforts to cling to a protocol that would keep school age children masked is abhorrent.

As discussed and approved by the Board of Trustees at the Board's regular meeting on April 15, 2021, Round Rock ISD's <u>mask</u> requirement will remain in place for all District schools and facilities through the 2020-2021 Spring semester.

The District's mask protocol states that students, staff members, and visitors should wear masks on buses, other District vehicles, inside school buildings, and anywhere on school grounds. This requirement includes during District events that take place during and outside of school hours. The only exception is that students have the option to remove their masks during outdoor activities, such as P.E. class and recess, providing they can appropriately social distance from others.

The District administration is aware that some families have recently interpreted the phrase "should wear masks" as optional. It is not. This protocol has been an expectation and requirement for the entire school year, and that requirement has not changed. Any student participating in on-campus learning for the duration of the school year must comply with the mask protocols. Students who do not wish to comply may opt for virtual learning.

A complete overview of the District's mask protocols can be found in the <u>Health and Safety Protocols Guide</u>. Round Rock ISD's current <u>COVID-19 mitigation strategies</u> are designed with the guidance of local health agencies. Currently, both <u>Williamson</u> <u>County and Cities Health District</u> and <u>Austin Public Health</u> recommendations regarding masks and social distancing have not changed.

This letter serves as a notification that according to current RRSD COVID masking protocols, will no

longer be wearing a mask beginning Friday, April 23rd, one day after the Outy of Round Rock mask mandate

expires. I request that the school and RRSD immediately make a school/district wide darifying announcement

The link below takes you to a study quietly published on CDC.gov that shows a 1.8% or less correlation to a reduction in COVID cases when states instituted a mask mandate. In addition, it also shows a less than 2% increase in cases for states that opened up in-person dining. You'll notice that it mentions that masking provided what they call a "significant decrease" in cases, but 1.8% is hardly significant given the many variables.

The link below takes you to a study quietly published on CDC.gov that shows a 1.8% or less correlation to a reduction in COVID cases when states instituted a mask mandate. In addition, it also shows a less than 2% increase in cases for states that opened up in-person dining. You'll notice that it mentions that masking provided what they call a "significant decrease" in cases, but 1.8% is hardly significant given the many variables.

I think this is great information for the argument to make masks optional, especially in areas like the classroom where students are seated, similar to restaurant dining.






Attached is a screenshot of one of the pages from it.

Who wrote these? Who approved these?



If you refuse to allow parents and students to have the choice to mask when

President Weir, Dr. Azaiez and RRISD Legal Services,

I see that there is a called board meeting to discuss COVID protocols on Monday 8/16/21. I'm making an assumption here, but I am guessing that it relates to making a decision on mandatory masking.

I'd like to remind you all that the board voted 5-2 to dismiss our Level III complaint, denying us due process, and citing that what we were requesting was outside the authority of the board due to Governor Abbott's Executive Order GA-36.

In addition, on August 3rd, 2021, the Superintendent designee, on behalf of the Board of Trustees sent us the attached Level III dismissal letter stating, "Governor Abbott's Executive Order No. GA-36 provides "school districts cannot require any person to wear a face covering after June 4, 2021. The Executive Order remains in effect indefinitely." At the end of this letter of dismissal, it also states "In accordance with Board Policy FNG(LOCAL) this decision shall be final action on the grievance by the District."

By your own admission in this document, you do not have the authority to make a decision that violates Governor Abbott's Executive Order GA-36. I hope that you will keep this in mind when discussing this decision on Monday.

Hello President Weir and Dr. Presley,

There is a very troubling private Facebook (FB) group that has been brought to my attention called "Teachers of Round Rock" (ToRR). There are about 1,200 members in this group, and a number of teachers have made disparaging comments about parents, and gossiping about ongoing trustee legal matters. I have numerous screenshots I can share as evidence. Even more concerning is that trustee Tiffany Harrison is participating in a number of these conversations that bring her ethics as a trustee into question, and she also may have used her position of power to influence the removal of a teacher for having a difference of opinion.

The most egregious comment came from trustee Tiffany Harrison on 3/14/21, when she told teachers in the FB group that she had already made up her mind to vote for continuing student masking at the upcoming board meeting scheduled for 4/15/21, without having heard comments from the public, or debate from her peers during the session. This is unethical appalling behavior by a trustee, and speaks volumes about her disregard for local trending data and thoughts and ideas that are different from her own. Furthermore, it flies contrary to diversity and inclusion by ignoring a marginalized group of parents, by coming to a decision before hearing from that group. This is the very definition of prejudicial oppression, and suppression of freedom of thought and freedom of speech. (screenshot of her comment is attached)

In addition, I have a number of screenshots of disparaging teacher comments and conversations, and a recent screenshot of a comment by trustee Harrison implying that I am a hateful person for a post that I made (using a SHAC board agenda item) to prompt the public to attend the meetings (see attached screenshot). One of the substitute teachers in the group, a friend of mine, took a screenshot of Ms. Harrison's comment, and sent it to me. I sent Trustee Harrison an email informing her that I was aware of her comment, and I asked her to make such comments in public or directly to me instead of to teachers in a private FB group. Approximately two hours after that email, my friend was removed from that Facebook group.

My friend's comment was not inflammatory, so there is reasonable suspicion that she was removed from the group at the request of Trustee Harrison. I cannot prove this, but if she did not make this request using her position of influence, it is quite the coincidence. My friend followed up with the group admin about being removed and was told that it was because she was not a teacher. However, she is a substitute teacher for RRISD and has been a member of the group for about a year, yet Trustee Harrison is not a teacher and is still a member of the FB group.

The justification given by the admin, the fact that Trustee Harrison is still a member of the group despite not being a teacher, and the timeliness of her removal from the group after the

comment leads me to believe that Trustee Harrison was responsible for her removal. This is oppressive behavior that seeks to "cancel" minority views, and is unbecoming of a trustee that is supposed to be a leader and advocate for not just teachers, but parents and students as well.

In the RISD employee handbook, under "Personal Use of Electronic Communications, it states, "As role models for the District's students, employees are responsible for their public conduct even when they are not acting as District employees. Employees will be held to the same professional standards in their public use of electronic communications as they are for any other public conduct." This type of behavior goes against this policy, and is not reflective of a role model for RR district students, and goes against the RRISD professional standards that a teacher is expected to exhibit as a representative of the district.

I can't think of one corporate or government organization that would condone their staff and board members being a part of a FB group that engages in disparaging gossip about their stakeholders (parents), and also uses the platform to silence teachers that do not agree with certain board members positions. I hope you will address this immediately.

I'm asking for four things to rectify this situation:

1. A public apology from Trustee Harrison during the June regular board meeting for both of her actions.

2. Either a formal censure of Trustee Harrison's Facebook voting comments during the June regular board meeting, or that her vote be stricken from the 4/15 agenda item L record.
 3. That the district release an email statement apologizing to parents for the disparaging FB behavior of the teachers.

4. Require teachers and board members to remove themselves from the ToRR FB group, and inform RRISD teachers and trustees that this behavior is not tolerated in this district.

I understand that teachers have a first amendment right in their individual capacity, and that the ToRR group is not an official RRISD page, but condoning an environment where disparaging comments spread like a virus, only serves to foster potential hate, division and biases against

I will be filing a formal complaint on Trustee Harrison's FB voting comment made ahead of the 4/15 meeting. If swift action is not taken with teacher and trustee use of the ToRR FB page, I will consider sharing these screenshots and this story with local media outlets.

If you'd like, I am willing to meet with you both to review the screenshots attached, and others that I have.
