After watching the board meeting, I want to make it abundantly clear that offering a virtual school is not a true viable option at this point in the game. There are a lot of families that want virtual for reasons far beyond medically necessary. Virtual learning is not the same level as in person. It is not fair for those learning virtually to compete in the same classes or for gpa's as on campus. This is not remotely that same education and if you decide to choose to offer this unfunded resource then it has to be on a very limited basis and it needs to be similar to home bound. There are a lot of other options that can offer a much better solution. As it was said, RRISD needs to focus on its public education that is in person. I also strongly believe if a family needs this virtual option then you do not need access to extracurricular activities. You can not claim you need virtual then turning around and are accessing extracurricular activities that is where covid spread is more likely. I'm very concerned that some board members do not fundamentally understand their fiduciary duties. I love Dr Bones idea of offering partnerships and looking outside the box is brilliant. Public school does not work for everyone that is just the way it is. I also appreciate that Dr Bone acknowledges that when we are taking money from one child and redistributing it may create equity issues and acknowledging that the shoe is on the other foot for those that are now being told they may need to find other options. 4 Board members didn't care when people were willing to find other options last year. I'm growing tired of the childish, emotional outbursts by board members that seem to think we have unlimited tax money to throw around.

I stand by Mrs. Weston's stance that if it is offered it needs to be very limited in scope. The fact is that most of these families that are wanting virtual options are more based on fear and lack of vaccines under 12 versus the real need for virtual education. The comment about spread after receiving the vaccine is so rare that it does not warrant spending \$8K per person when we have so many educational gaps, emotional issues and so forth that were all very documented. Unfortunately, the district does have constraints and that is public education. That will not change in the near future. The community will adjust and be confident if the board and administration is confident in their plan.

I also want to be sure that the RRISD board is accounting for the increase in the homestead exemption that williamson county and I think travis county did for this year. I'm happy to send this link if needed.

On 5/21/21, the district announced the sole finalist of Dr. Azaiez. The next step is to spend a minimum of 21 days asking the sole finalist questions and engaging the public. AISD offered 3 townhall meetings for constituents while RRISD didn't even research the possibility of offering the same transparency.
