We have a significant breakdown in security, safety, and evidence chain of custody that needs to be addressed immediately. I made a similar request for the video surveillance footage of the assault and harassment incident that occurred 10/21 board meeting, and the open records team has informed me that it does not exist (see below). I have seen the cameras in that hallway, and at the entrance of bldg 100, so they do exist.

I asked Chief Yarbrough on 10/25 to be sure the video evidence was preserved. When we met with Officer Marquez on 10/29 to make this report, we asked about the length of time that video surveillance is stored. I audio recorded our entire conversation with Officer Marquez (with his knowledge), and below is some of the transcript in regards to preserving video surveillance of a reported crime.

Officer Marquez was asked the following:

Ricci Nelson: "By filling this out [the police report], will it ensure that you preserve any video that you have?"

Office Luis Marquez: "Oh, yeah. Yes ma'am. We have to attach whatever video there is [to the report]. We would download that video and preserve it and add that to our evidence cloud, and it's attached to the case and class C offenses will usually stay on for, I believe, about, since it's an assault, about two years."

Based on the Open Records Team's response, and the response from Officer Marquez, I have some questions I would like to have answered.

- 1) Why is there no responsive information [stored video] regarding our request?
- 2) Are the specified cameras operational?
- 3) If the cameras are operational, did Chief Yarbrough/RRISD PD not preserve the video evidence of the crime as requested?
- 4) If the cameras are not operational, why not and how long have they not been operational?
- 5) Was the video overwritten?

Board of Trustees, Dr. Azaiez,

I want to make you aware of a concerning safety issue at a board meeting that I don't believe has been properly addressed by RRISD PD. I am hoping that either the BoT or Dr. Azaiez can look into this matter further, determine who the perpetrator was, and issue a restraining order on him.

On Monday October 25th, I contacted Chief Yarbrough via email about an assault and a harassment incident that occurred at the 10/21/21 board meeting, both committed by the same man. While the board was in the first closed session, and we were asked to wait outside the boardroom, this man grabbed an Asian woman by both of her shoulders and pushed her aside in the hallway as he walked by. After moving her aside, he continued on and stopped and spoke with a woman named Jenn Brown. Later that night, he sat with a woman named Lindsey Ledyard. We do not know the name of the man, but Jenn Brown attends almost every board meeting. I have attached a picture from the board meeting camera of the man in question.

Later that night, as I was leaving the meeting with my wife and Christie Slape, this same man confronted us on the stairs leading out of bldg100 and proceeded to verbally harass me and berate me for the public comments I made during the meeting. I have thick skin, and have no issue defending myself if needed, but this was very concerning given the earlier physical altercation. Both of these incidents occurred in view of RRISD security cameras, and the perpetrator's vehicle and license plate should be in view of the outdoor camera.

On October 26th, I received a response from Chief Yarbrough to schedule a meeting with Officer Luis Marquez.

On October 29th, I met with Officer Luis Marquez, along with the Christie Slape, Ricci Nelson, and the victim. During this meeting, the victim gave her statement, but was reluctant to press charges and seek a restraining order because she feared that this man would stalk her at her home. The victim stated to Officer Marquez that she will no longer come to the school board meetings because she is fearful of what this man might do. Christie Slape and I also gave a statement.

I was not given a police report number initially, but I followed up with Officer Marquez, and he provided it to me. I also asked him for a copy of the police report, but he said I would need to go through Open Records to get a copy. I submitted a request to Open Records on 11/3/21, and have still not received a copy, well past the 10 business days required by law. This is very concerning given that I am aware of dozens of people who are experiencing the same issue with the RRISD Open Records department.

I request an RRISD restraining order be given to this man for the assault, and that the BoT look into the issues plaguing the RRISD Open Records dept.

BoT and Superintendent,

It seems there is a staffing and accountability issue that is not being dealt with in our legal department, and I was hoping the BoT or Superintendent could help resolve this issue before it becomes a costly financial issue in the courts.

A parent in the district sent me the below communication that he received from the RRISD open records team today. It is very concerning because this has become a troublesome trend for most parents/stakeholders, and it is opening our school district up to legal risk, and I believe we are already hemorrhaging money via legal fees.

It is even more concerning because the open records legal team is unlawfully refusing to seek an AG determination as is required by law in the Texas Public Information Act. This lawlessness needs to stop. The school district and it's **legal department does not have the authority to decide** what they are allowed to withhold, that authority rests with the Texas AG's office. Texas Public Information Act Section 552.301, subsections (a) and (b), provides that when a governmental body receives a written request for information the governmental body wishes to withhold, it *must* seek an attorney general decision within ten business days of its receipt of the request and state the exceptions to disclosure that it believes are applicable.

For almost two months now, the open records dept has been missing the ten business days required by law to produce public records and information. Most all parents/stakeholders receive an email saying that there has been a lot of turnover and an influx of requests, and that their request will not be fulfilled within the 10 business days. Neither are excuses for breaking the law, and doing so for almost two months now.

The below bullet points are the original open records request from 8/31. The parent who made the request followed up multiple times, and just received a response today from legal denying him the records.

A copy of all email communications from any AISD or Travis County elected official, sent to Dr. Hafedh Azaiez or Amy Weir regarding wearing of masks or mask opt outs from 8/9/21 - 8/27/21.



On Monday October 25th, I contacted Chief Yarbrough via email about an assault and a harassment incident that occurred at the 10/21/21 board meeting, both committed by the same man. While the board was in the first closed session, and we were asked to wait outside the boardroom, this man grabbed an Asian woman by both of her shoulders and pushed her aside in the hallway as he walked by. After moving her aside, he continued on and stopped and spoke with a woman named Jenn Brown. Later that night, he sat with a woman named Lindsey Ledyard. We do not know the name of the man, but Jenn Brown attends almost every board meeting. I have attached a picture from the board meeting camera of the man in question.

Later that night, as I was leaving the meeting with my wife and Christie Slape, this same man confronted us on the stairs leading out of bldg100 and proceeded to verbally harass me and berate me for the public comments I made during the meeting. I have thick skin, and have no issue defending myself if needed, but this was very concerning given the earlier physical altercation. Both of these incidents occurred in view of RRISD security cameras, and the perpetrator's vehicle and license plate should be in view of the outdoor camera.

On October 26th, I received a response from Chief Yarbrough to schedule a meeting with Officer Luis Marquez.

On October 29th, I met with Officer Luis Marquez, along with the Christie Slape, Ricci Nelson, and the victim. During this meeting, the victim gave her statement, but was reluctant to press charges and seek a restraining order because she feared that this man would stalk her at her home. The victim stated to Officer Marquez that she will no longer come to the school board meetings because she is fearful of what this man might do. Christie Slape and I also gave a statement.

I was not given a police report number initially, but I followed up with Officer Marquez, and he provided it to me. I also asked him for a copy of the police report, but he said I would need to go through Open Records to get a copy. I submitted a request to Open Records on 11/3/21, and have still not received a copy, well past the 10 business days required by law. This is very concerning given that I am aware of dozens of people who are experiencing the same issue with the RRISD Open Records department.

I request an RRISD restraining order be given to this man for the assault, and that the BoT look into the issues plaguing the RRISD Open Records dept.

We have a significant breakdown in security, safety, and evidence chain of custody that needs to be addressed immediately. I made a similar request for the video surveillance footage of the assault and harassment incident that occurred 10/21 board meeting, and the open records team has informed me that it does not exist (see below). I have seen the cameras in that hallway, and at the entrance of bldg 100, so they do exist.

I asked Chief Yarbrough on 10/25 to be sure the video evidence was preserved. When we met with Officer Marquez on 10/29 to make this report, we asked about the length of time that video surveillance is stored. I audio recorded our entire conversation with Officer Marquez (with his

knowledge), and below is some of the transcript in regards to preserving video surveillance of a reported crime.

Officer Marquez was asked the following:

Ricci Nelson: "By filling this out [the police report], will it ensure that you preserve any video that you have?"

Office Luis Marquez: "Oh, yeah. Yes ma'am. We have to attach whatever video there is [to the report]. We would download that video and preserve it and add that to our evidence cloud, and it's attached to the case and class C offenses will usually stay on for, I believe, about, since it's an assault, about two years."

Based on the Open Records Team's response, and the response from Officer Marquez, I have some questions I would like to have answered.

- 1) Why is there no responsive information [stored video] regarding our request?
- 2) Are the specified cameras operational?
- 3) If the cameras are operational, did Chief Yarbrough/RRISD PD not preserve the video evidence of the crime as requested?
- 4) If the cameras are not operational, why not and how long have they not been operational?
- 5) Was the video overwritten?

Firstly, thank you for coming to Round Rock ISD to monitor our Board of Trustees. As I'm sure you're aware, our district and its elected trustees are at the center of quite a few controversies and I'm optimistic that close guidance will help right the ship, so to speak.

Second, I have a question about the ethical guidelines as they related to elected Trustees' use of social media on their official candidate/official pages. Below you will see a screen shot from Dr. Jun Xiao's Trustee Facebook page in which he links a website, additional screen shots from that site are also linked. The website solicits donations for a political candidate for Texas Legislature, and Dr. Xiao appears to be supporting or endorsing this site. Is this an ethical violation, in your professional opinion.

To put it further into context, the person the runs that website is linked to an alleged assault on 10/21 and serious claims of online bullying/harassment of community members/trustee Bone/trustee Westin. The online harassment was so bad I had to file a police report and fear for my personal safety. These concerns have been reported to the board, superintendent and Chief Yarbrough but no action or investigation has been taken. Myself and Dustin Clark did an open records request for video of the alleged assault shortly after the encounter but we're just informed nearly twice months later that no video was available. We both reached out to the same group mentioned above asking for an explanation and again silence. Was it deleted? Are the cameras not operational? What are they hiding?

With all the being said, I'm requesting a censure of trustee Xiao, deleting of the fb post and a public apology that explains his violations of his code of ethics. I will be following up with a level 3 complaint with rrisd, tea and Texas ethics commission complaints as I'm confident trustee Xiao violated campaign finance laws as well.

During the first closed session break of the 10/21/21 board meeting, I witnessed a man aggressively grab Jennifer Dieterle by both shoulders and move her aside as he barreled through the hallway to get to his friend on the other side. The friend's name is Jenn Brown (see attached pic).

When the second closed session began, my wife and I were leaving the building with our friend Christie Slape, and this same man approached us in the parking lot and got very confrontational with me as though he was trying to intimidate me. When we didn't back down, he shouted some expletives and then walked quickly to his car, got in, and drove off. He was driving a black Lexus, but we didn't think to get the license plate.

We have been trying to identify the man's name, but have been unsuccessful. We believe the hallway that leads to the board room has cameras, and would like the video evidence of the assault to be preserved from that night.

We also believe this may be the same man that Ricci Nelson has recently raised concerns about to you. His name might be Jack Chiles or a man named Jason Schklar. Also, attached are pictures of the man in question as he was sitting in the board room. In the picture, a woman is sitting next to him, and her name is Lindsey Ledyard (pic attached) she can likely identify the name of the man. She spoke during public comments, but he did not. I've also included social media posts that show the hostile nature of Mr. Schklar towards RRISD parents who do not wear masks.

Good afternoon,

The Board has opted to not list any action items on the agenda for tomorrow's Called Board Meeting, which ultimately means that the public will not have a chance to provide comment on the employment and performance of Superintendent Azaiez. Therefore, I would like to submit my concerns via email instead, in the hopes that these issues will be properly and exhaustively addressed during closed session.

Considering the grandiose nature of Dr. Azaiez's unprecedented contract (providing him up to nearly \$400,000 in annual compensation, in addition to \$10,000 for a moving stipend, \$8400 annually for an automobile stipend, and a cell phone allowance each month) in the context of a great revenue loss and tax rate increase for the community, it is worthwhile to scrutinize whether he has failed to live up to the terms of this agreement.

Even before the contract was signed, there were a number of issues brought forth to the Board, such as his alleged use of police in Donna ISD to prevent a vocal citizen from participating in the democratic process. Alas, the Board opted (5-2) to move forward with hiring Dr. Azaiez in a less than transparent way, despite the lack of vetting and dearth of interviews with other viable and qualified candidates. This does not even take into account that, as a candidate, Dr. Azaiez was provided a hotel room during his interview, at the taxpayers' expense and allegedly used that hotel room to have an extramarital rendez-vous.

Almost immediately after he took on the position of Superintendent, more red flags began to emerge. In the interest of brevity, I will provide a concise timeline of troubling events:

- June 28, 2021 Dr. Azaiez becomes aware that his girlfriend ("Jane Doe"), a high level administrator in a neighboring school district, is pregnant, allegedly with his child, and he demands via text message that she terminate the baby; she refuses. He threatens violence against her out of concern for his reputation
 - July 5, 2021 A friend of "Jane Doe" reaches out to Trustee Cory Vessa to disclose details of Dr. Azaiez's behavior, Trustee Vessa responds on July 6
- July 6, 2021 Dr. Azaiez allegedly tells "Jane Doe" that board members informed him she had attempted to communicate with them about the affair and his threats. He then allegedly goes to her home to convince her to have an abortion and while he is there, according to "Jane Doe", he assaults her. Later, "Jane Doe" goes to the hospital for exams out of concern for her baby due to spotting, bruises are seen
- July 14, 2021 "Jane Doe" emails board members, requesting that they contact her so she can provide them with details about his alleged criminal and moral wrongdoing
- July 18, 2021 The home of "Jane Doe" is burglarized; only items missing are her iPad, laptop and personal diary, which was stored in her bedside table
- July 23, 2021 Community member Jeremy Story writes an email to the board, informing them of the allegations, asking that they investigate the incident fully; his requests are denied or ignored by all but two Trustees
- August 2, 2021 Dr. Azaiez is served with an initial protective order at his office in the RRISD Administrative building
- August 6, 2021 Board members issue a press release denying knowledge of allegations August 12, 2021 - Mr. Story again writes the board with concerns, urging immediate action on the allegations

August 16, 2021 - Mr. Story is restrained and removed from a board meeting for expressing safety concerns related to Dr. Azaiez

August 19, 2021 - Board and Dr. Azaiez sign agreement to follow TEA disciplinary/oversight process September 2021 - COVID-related TOMA restrictions lifted

September 4, 2021 - Mr. Story submits a formal grievance to Legal Services over his removal from the 8/16 meeting, but he is redirected by district police to go to outside law enforcement

September 9, 2021 - David Carmichael, Staff Investigator with Texas Education Agency, sends letter to Dr. Azaiez to inform him that the State Board for Educator Certification has received information that "could potentially impact [his] Texas educator certificate" and that TEA Educator Investigations Division has "opened a case file to review and investigate this information". The allegation listed is "assault".

September 17, 2021 - Williamson County Sheriffs execute district police arrest warrants for Mr. Story and Mr. Clark, apprehending them at their homes on a Friday evening, they must spend the night in jail

October 1, 2021 - a secondary protective order is issued, alleging a "clear and present danger of family violence" against "Jane Doe"

Additionally, there have been attempts to silence two dissenting Trustees by way of overreaching censures. There have also been concerns raised about Dr. Azaiez's principal address, which is contractually required to be within the district, yet his voter registration and drivers license list an address in Weslaco and his family resides in Cypress. Recently, he recommended that the board adopt draconian policies which would put police officers under his direct supervision to enforce school policies like dress code.

At the very minimum, this board should be seriously considering unpaid Administrative Leave for Dr. Azaiez while his criminal and educator certification matters are investigated fully. In his short time as Superintendent, he has managed to divide the community, use force to silence the voices of concerned parents and taxpayers, and put a stain on our district as various media outlets report on his behavior and actions.

Please approach tomorrow's session through a lens of logic, fiscal responsibility, and the safety and security of our students and staff.

Good morning,

The Board has opted to not list any action items on the agenda for today's Called Board Meeting, which ultimately means that the public will not have a chance to provide comment on the employment and performance of Superintendent Azaiez. Therefore, I would like to submit my concerns via email instead, in the hopes that these issues will be properly and exhaustively addressed during closed session.

Considering the grandiose nature of Dr. Azaiez's unprecedented contract (providing him up to nearly \$400,000 in annual compensation, in addition to \$10,000 for a moving stipend, \$8400 annually for an automobile stipend, and a cell phone allowance each month) in the context of a great revenue loss and tax rate increase for the community, it is worthwhile to scrutinize whether he has failed to live up to the terms of this agreement.

Even before the contract was signed, there were a number of issues brought forth to the Board, such as his alleged use of police in Donna ISD to prevent a vocal citizen from participating in the democratic process. Alas, the Board opted (5-2) to move forward with hiring Dr. Azaiez in a less than transparent way, despite the lack of vetting and dearth of interviews with other viable and qualified candidates. This does not even take into account that, as a candidate, Dr. Azaiez was provided a hotel room during his interview, at the taxpayers' expense and allegedly used that hotel room to have an extramarital rendezvous.

Almost immediately after he took on the position of Superintendent, more red flags began to emerge. In the interest of brevity, I will provide a concise timeline of troubling events:

June 28, 2021 - Dr. Azaiez becomes aware that his girlfriend ("Jane Doe"), a high level administrator in a neighboring school district, is pregnant, allegedly with his child, and he demands via text message that she terminate the baby; she refuses. He threatens violence against her out of concern for his reputation July 5, 2021 - A friend of "Jane Doe" reaches out to Trustee Cory Vessa to disclose details of Dr. Azaiez's behavior, Trustee Vessa responds on July 6

July 6, 2021 - Dr. Azaiez allegedly tells "Jane Doe" that board members informed him she had attempted to communicate with them about the affair and his threats. He then allegedly goes to her home to convince her to have an abortion and while he is there, according to "Jane Doe", he assaults her. Later, "Jane Doe" goes to the hospital for exams out of concern for her baby due to spotting, bruises are seen July 14, 2021 - "Jane Doe" emails board members, requesting that they contact her so she can provide them with details about his alleged criminal and moral wrongdoing

July 18, 2021 - The home of "Jane Doe" is burglarized; only items missing are her iPad, laptop and personal diary, which was stored in her bedside table

July 23, 2021 - Community member Jeremy Story writes an email to the board, informing them of the allegations, asking that they investigate the incident fully; his requests are denied or ignored by all but two Trustees

August 2, 2021 - Dr. Azaiez is served with an initial protective order at his office in the RRISD Administrative building

August 6, 2021 - Board members issue a press release denying knowledge of allegations

August 12, 2021 - Mr. Story again writes the board with concerns, urging immediate action on the allegations

August 16, 2021 - Mr. Story is restrained and removed from a board meeting for expressing safety concerns related to Dr. Azaiez

August 19, 2021 - Board and Dr. Azaiez sign agreement to follow TEA disciplinary/oversight process September 2021 - COVID-related TOMA restrictions lifted

September 4, 2021 - Mr. Story submits a formal grievance to Legal Services over his removal from the 8/16 meeting, but he is redirected by district police to go to outside law enforcement

September 9, 2021 - David Carmichael, Staff Investigator with Texas Education Agency, sends letter to Dr. Azaiez to inform him that the State Board for Educator Certification has received information that "could potentially impact [his] Texas educator certificate" and that TEA Educator Investigations Division

has "opened a case file to review and investigate this information". The allegation listed is "assault". Firstly, thank you for coming to Round Rock ISD to monitor our Board of Trustees. As I'm sure you're aware, our district and its elected trustees are at the center of quite a few controversies and I'm optimistic that close guidance will help right the ship, so to speak.

Second, I have a question about the ethical guidelines as they related to elected Trustees' use of social media on their official candidate/official pages. Below you will see a screen shot from Dr. Jun Xiao's Trustee Facebook page in which he links a website, additional screen shots from that site are also linked. The website solicits donations for a political candidate for Texas Legislature, and Dr. Xiao appears to be supporting or endorsing this site. Is this an ethical violation, in your professional opinion.

To put it further into context, the person the runs that website is linked to an alleged assault on 10/21 and serious claims of online bullying/harassment of community members/trustee Bone/trustee Westin. The online harassment was so bad I had to file a police report and fear for my personal safety. These concerns have been reported to the board, superintendent and Chief Yarbrough but no action or investigation has been taken. Myself and Dustin Clark did an open records request for video of the alleged assault shortly after the encounter but we're just informed nearly twice months later that no video was available. We both reached out to the same group mentioned above asking for an explanation and again silence. Was it deleted? Are the cameras not operational? What are they hiding?

With all the being said, I'm requesting a censure of trustee Xiao, deleting of the fb post and a public apology that explains his violations of his code of ethics. I will be following up with a level 3 complaint with rrisd, tea and Texas ethics commission complaints as I'm confident trustee Xiao violated campaign finance laws as well.

They were filed last Friday with Officer Marquez. I know that Mr Yarborough was notified of the incidents as well as the increased harassment online. I'm not sure the process from an administrative side and investigative procedures. I can tell you the victim was fearful for her safety and was considering if she wanted to press charges. She was visibly afraid for her safety in the meeting with Officer Marquez. We provided Officer Marquez a picture of the suspect and asked him to be identified by this Friday. It's absolutely unacceptable that I sit here a week later not knowing if the person in the picture provided is the same person harassing me and 6 others online, assaulted jennifer and confronted Dustin/Christie outside in the parking lot or if they are two different people. I can also tell you that the person harassing me online is followed by a private Twitter account operated by Tiffanie Harrison @youngtiffanie.

I'm struggling to understand why this is not being taken seriously by the district. This information is critical to me obtaining a TRO.

I'm sure the reports can be provided by the RRISD police.

Dr Azaiez,

Today your staff sent out an email to the community announcing that effective today, the district will follow a CDC color coded matrix that was developed in Atlanta, GA as the premises for the masking of children in RRISD. Your staff announced that you are making this change because the WCCHD has abandoned its color coded gating criteria. I do not understand what is going on with this announcement. They board never discussed or voted on utilizing the CDC's color coded system to make mask decisions. The WCCHD is not recommending any color codes anymore, it simply offers a link to an out-of-state federal agency as an FYI to visitors to their website. To be clear, the WCCHD does not recommend any color codes to anyone. This is evidenced by the fact that not a single WCCHD board member wore a mask in last week's (10 Nov 2021) board meeting (held in a very public setting) in which they announced their abandonment of recommending any color codes effective 15 Nov.

Making a policy change without board approval is one problem. Another problem is making a policy change (disregarding APH and utilizing the CDC) that means that Covid will have to be virtually eliminated in order for masks to be optional in RRISD. Is that your goal? We never get to numbers that low with the flu and yet never ask students to wear masks during flu season. Not even in the 2014-2015 flu season when over 800 children died of the

flu: <u>https://www.cdc.gov/flu/about/burden/2014-2015.html</u> According to the CDC website, 595 children have died of Covid over the last two years: <u>https://data.cdc.gov/widgets/9bhg-hcku?mobile_redirect=true</u>

I have tried to operate within the confines that exist in common sense and problem solving on this. But I find you unreceptive to reacting appropriately to the facts as demonstrated by today's announcement from your staff.

According to the document passed by the board on 22 Sep, the only entity listed with a color coded guide for mask recommendations is APH. Moving the goal posts around is not acceptable in my view, undermines trust in our community and does not serve children.

Do I need to go into the fact that you just had 350 members of a RRISD high school band on a trip out of state and they were often crammed into a confined space in a convention center with scores of other enormous bands from across the country and less that 5% were ever wearing a mask? I have the pictures. And this goes for the staff and the many parents (several of whom are employed by RRISD) up there mask free. Help me understand how students are supposed to make sense of the hypocrisy? Because that's who I care about. Not being a hypocrite in front of children.

The change from WCCHD today represents an opportunity to pivot on this issue, unite our community and move forward. Why do you instead double down on modeling hypocrisy to students?

How do you recommend we proceed if the superintendent is not following the motion that the board approved in the 22 Sep 2021 meeting? I provided time stamps and detailed motion language from that meeting higher up in this thread.

I will remind all of you that no other school district in Williamson County has mandated masks for weeks. There has been no escalation in cases, hospitalizations or deaths as a result. ZERO.

Please tell me which of the two paths we are going down. We need clarity in our community.



It's been over 24 hours and I have not heard back from you on this consequential matter. Will we be going with APH's stages (as your matrix says) or holding another meeting on masks?

I just watched the 22 Sep 2021 board meeting again. I would point you to the minutes of the meeting so you'd know what was voted on and when but the approval of the minutes for this meeting have not come to the board for approval.

At the 2:52:00 mark, Dr Azaiez says, "we aligned the matrix with the Williamson County and Cities Health District and Austin Public Health. We'd like to get your support for this mask matrix."

At the 2:57:00 mark, Trustee Feller says, "

At the 3:12:30 mark, Trustee Xiao makes the following motion, "I move that the board direct the administration to make future decisions regarding masks in accordance with the matrix presented and or legally issued court orders or TEA enforcement."

At the 3:15:40 mark Trustee Feller says, I like that this is tied to a matrix and that there is a light at the end of the tunnel. We entered into stage 4 in Austin yesterday. If the decline keeps going, we could be in stage 3 in two weeks. That;s what I've supported, wearing masks until community spread is less."

Then at the 3:18:10 mark the sound goes out, hands are raised apparently in a vote on the motion made by Xiao. Again, we have no minutes to offer to confirm anything. It appears to an observer that the board passed Xiao's motion.

I have included a screenshot from the WCCHD covid dashboard for data (number of cases) from Sep to Nov 2021. As you can see, around the time of the 22 Sep 2021 board meeting, the data was at its peak. It has since fallen like a rock in Williamson county. I also have a screenschot of every single day of data fro the WCCHD website which captures the number of new daily cases. I see that the peat was on Sep 15 (551 cases) and Sep 23 (427 cases). Again, the dta has fallen like a rock. Today the number of new cases in WillCo with it's 650k residents is 54 new cases. As evidenced by the fact that no other ISD in WilCO is asserting they are in "Red", there is no reason based on the data that RRISD should still be in Red.

As I told you yesterday in this email thread, the color coded chart that the WCCHD adopted in Sep 2020 has been abandoned by the WCCHD. Effective 15 Nov, they will no longer use it or have it on their website. This is the chart your board approved matrix is based on when you listen to the motion made by Xiao in the 22 Sep meeting. Again, either the matrix needs to now just rely on APH (as is listed on the matrix) or we need another meeting ASAP to address this. Please let me know what you decide. We need resolution quickly.
