ON OCTOBER 21, 2021, I ATTENDED THE RRISD BOARD MEETING IN THE RRHS 100 BLDG. AS I WAS LEAVING THE MEETING WITH DUSTIN AND RACHELLE CLARK, A MAN WHO JUST PREVIOUSLY ASSAULTED MY FRIEND JENNIFER DIETERLE IN THE HALLWAY, APPEARED NEXT TO US IN THE PARKING LOT. IT WAS DARK. HE BEGAN SPEAKING TO DUSTIN IN A COMBATIVE TONE, REFERRING TO THE BOARD MEETING. THE MAN CONTINUED TO WALK BESIDE US AND RESPONDED TO DUSTIN TELLING HIM, "I DON'T GIVE A F**K ABOUT YOU" AND "FVCK OFF". IT WAS VERY INTENSE AND I FELT LIKE HE COULD INITIATE A FIGHT. HE GOT IN HIS CAR (BLACK LEXUS SEDAN) AND LEFT ABRUPTLY.
