On Monday October 25th, I contacted Chief Yarbrough via email about an assault and a harassment incident that occurred at the 10/21/21 board meeting, both committed by the same man. While the board was in the first closed session, and we were asked to wait outside the boardroom, this man grabbed an Asian woman by both of her shoulders and pushed her aside in the hallway as he walked by. After moving her aside, he continued on and stopped and spoke with a woman named Jenn Brown. Later that night, he sat with a woman named Lindsey Ledyard. We do not know the name of the man, but Jenn Brown attends almost every board meeting. I have attached a picture from the board meeting camera of the man in question.

Later that night, as I was leaving the meeting with my wife and Christie Slape, this same man confronted us on the stairs leading out of bldg100 and proceeded to verbally harass me and berate me for the public comments I made during the meeting. I have thick skin, and have no issue defending myself if needed, but this was very concerning given the earlier physical altercation. Both of these incidents occurred in view of RRISD security cameras, and the perpetrator's vehicle and license plate should be in view of the outdoor camera.

On October 26th, I received a response from Chief Yarbrough to schedule a meeting with Officer Luis Marquez.

On October 29th, I met with Officer Luis Marquez, along with the Christie Slape, Ricci Nelson, and the victim. During this meeting, the victim gave her statement, but was reluctant to press charges and seek a restraining order because she feared that this man would stalk her at her home. The victim stated to Officer Marquez that she will no longer come to the school board meetings because she is fearful of what this man might do. Christie Slape and I also gave a statement.

I was not given a police report number initially, but I followed up with Officer Marquez, and he provided it to me. I also asked him for a copy of the police report, but he said I would need to go through Open Records to get a copy. I submitted a request to Open Records on 11/3/21, and have still not received a copy, well past the 10 business days required by law. This is very concerning given that I am aware of dozens of people who are experiencing the same issue with the RRISD Open Records department.

Board of Trustees,

We have a significant breakdown in security, safety, and evidence chain of custody that needs to be addressed immediately. I made a similar request for the video surveillance footage of the assault and harassment incident that occurred 10/21 board meeting, and the open records team has informed me that it does not exist (see below). I have seen the cameras in that hallway, and at the entrance of bldg 100, so they do exist.

I asked Chief Yarbrough on 10/25 to be sure the video evidence was preserved. When we met with Officer Marquez on 10/29 to make this report, we asked about the length of time that video surveillance is stored. I audio recorded our entire conversation with Officer Marquez (with his knowledge), and below is some of the transcript in regards to preserving video surveillance of a reported crime.

## Officer Marquez was asked the following:

**Ricci Nelson:** "By filling this out [the police report], will it ensure that you preserve any video that you have?"

**Office Luis Marquez:** "Oh, yeah. Yes ma'am. We have to attach whatever video there is [to the report]. We would download that video and preserve it and add that to our evidence cloud, and it's attached to the case and class C offenses will usually stay on for, I believe, about, since it's an assault, about two years."

### OPEN RECORDS REQUEST RELATED TO VIDEO FOOTAGE

There have been several emails to the board questioning operations and procedures related to security video footage as the result of an Open Records Request. We wanted to alert the board that the emails included misinformation/misinterpretation of the response to the Open Records Request. There are several factors at play:

First, due to the current turnover and open positions in the legal services department, as well as a deluge of open records requests to address, the video footage from inside Building 100 from 6:30 to 7:00 pm. was no longer available when staff began working on the request. The video surveillance system keeps recordings on file until a certain amount of hours are reached (approximately 30 days worth) then deletes and begins recording again. However, due to the allegations of assault, Round Rock ISD Police had already reviewed this video related to the alleged incident. The incident referenced in the Open Records Request did not occur in the 6:30 to 7:00 p.m. timeframe. RRISD PD does have the video of the incident, but that has not been requested in an ORR. The footage of the parking lot was also reviewed by RRISD PD, but the license plate was not visible. Police did not archive it since it had no evidentiary value related to the reported assault and no longer have it in their possession. Finally, it is noteworthy to understand that Round Rock ISD does not release security footage in response to an Open Records Request. Instead, the legal services team submits a request for opinion from the Texas Attorney General's Office when a request for surveillance video is submitted. Those requests are routinely granted under Sections 418.182(a) and 552.108 (when applicable) of the Texas Government Code.

Board of Trustees,

We have a significant breakdown in security, safety, and evidence chain of custody that needs to be addressed immediately. I made a similar request for the video surveillance footage of the assault and harassment incident that occurred 10/21 board meeting, and the open records team has informed me that it does not exist (see below). I have seen the cameras in that hallway, and at the entrance of bldg 100, so they do exist.

I asked Chief Yarbrough on 10/25 to be sure the video evidence was preserved. When we met with Officer Marquez on 10/29 to make this report, we asked about the length of time that video surveillance is stored. I audio recorded our entire conversation with Officer Marquez (with his knowledge), and below is some of the transcript in regards to preserving video surveillance of a reported crime.

Officer Marquez was asked the following:

**Ricci Nelson:** "By filling this out [the police report], will it ensure that you preserve any video that you have?"

**Office Luis Marquez:** "Oh, yeah. Yes ma'am. We have to attach whatever video there is [to the report]. We would download that video and preserve it and add that to our evidence cloud, and it's attached to the case and class C offenses will usually stay on for, I believe, about, since it's an assault, about two years."

Based on the Open Records Team's response, and the response from Officer Marquez, I have some questions I would like to have answered.

- 1) Why is there no responsive information [stored video] regarding our request?
- 2) Are the specified cameras operational?
- 3) If the cameras are operational, did Chief Yarbrough/RRISD PD not preserve the video evidence of the crime as requested?
- 4) If the cameras are not operational, why not and how long have they not been operational?
- 5) Was the video overwritten?
- 6) What is the RRISD video surveillance storage policy?

Just wanted to let you know you put my safety at risk by not redacting my information on an open records request regarding jack chiles. By posting my open records requests online without my knowledge you have further put my safety at risk. It's SHAMEFUL we have a distrcit police force that does nothing to protect its community members. This group of people is also associated to a rrisd employee, involved in an assault and are know posting threatening tweets online but Chief Yarbrough has done nothing to investigate these issues. They still have not identified the perpetrator of the assault and he was at the last board meeting sitting with Jenn Brown. Trustee Harrison is connected to this group so maybe she can shed some light on who assaulted the Asian women.

I'll be reaching out to cedar park police, the local fbi office and my attorney to see if I can pursue legal action. I guess until someone gets really hurt or murdered by your inaction you keep sweeping these issues under the rug.

Board of Trustees,

I have recently learned from RRISD administration staff that the video of the the assault that occurred on 10/21/22 does in fact exist, but my request for access to it was denied, which is preventing me from pursuing a restraining order on the man in question. I saw that tomorrow's meeting agenda item M3 is in regards to the district and board safety and security measures, so the below information (some of it I have recently learned from RRSID staff) will be very relevant to your discussions.

The assault was committed by a white man against an Asian woman, and it occurred at ~7:15pm on 10/21/21.

Later that evening, that same man followed me, my wife and another woman as we left the meeting. Once outside, he proceeded to verbally harass and intimidate us at the bottom of the steps outside of the bldg 100 entrance.

Chief Yarbrough was made aware of the incidents via an email on 10/25/21. He directed us to setup an appointment with RRISD PD Officer Marquez for us to provide official statements. In that email to Chief Yarbrough, I requested that all video evidence be retained.

On 10/29/21, I went in person with the victim and two other witnesses to provide official written statements to Officer Marquez. During that meeting, Officer Marquez assured us that all video evidence related to these two incidents would be retained.

We also discussed with Officer Marquez that we observed a pattern of behavior by some community members that had become increasingly aggressive towards us and some of our friends at board meetings in recent weeks and months, and that a number of women were feeling afraid to walk to their cars at night during and after the meetings because of this. Officer Marquez was given the name of two known associates that the assailant spoke with that evening, one of which spoke during public comment that night, and had her arm around him while they sat together in the front row. The other woman attends almost every board meeting. Identifying this man should have been relatively easy.

The woman who was assaulted stated that she did not want to press charges because she feared this man would find her address and come to her home and harm her or her child, and she also stated that she is now too afraid to come back to a school board meeting. She has not been back to a board meeting since that incident on 10/21/21.

I have attached an audio clip of her stating this during the meeting with Officer Marquez. All parties in that meeting were aware that I was recording the meeting. This is a snippet of the recording of the entire meeting

You'll also notice that she mentions that she believes she saw this man at the September meeting (at McNeil PAC) and he was shouting at her outside.

I have recently learned from district staff that the video footage of the incident outside bldg 100 had somehow been determined to have no evidentiary value, so contrary to what Officer Marquez told us would happen, it was not retained.

My statement, and the statement of one of the other women, described the incident outside and pointed out that it was the same man that committed the assault, so why would it not have evidentiary value?

Who decided this, and why was the video of the second incident not retained since both incidents were committed by the same man within an hour or two of each other?

From information provided by a RRISD staff attorney, I have learned that the district has a policy to maintain video surveillance footage for "approximately 30 days," but I am unable to find this policy on the district website.

Does this policy truly exist, and is it 30 days, or approximately 30 days?? How is RRISD video surveillance stored? Local hard drive/server, or cloud server? Is the video overwritten, or is it manually or automatically deleted?

If it is manually deleted, who is responsible for deleting it?

I have also been informed that the video is part of an ongoing investigation, but here we are four months later, and this man continues to attend the board meetings. I am quite sure that with the available evidence and multiple eye witness testimonies, that at least a trespass warrant could be issued to deter this man from committing another act of violence.

My calls to look into this assault have largely been ignored, opening up the the district to significant risk regarding the safety and security of our students, community members, and trustees at board meetings. I am having trouble understanding why there seems to be a trend of high-level RRISD leaders and elected officials ignoring incidents of violence and intimidation against women. This now seems to be a RRISD pattern of willful ignorance.

I hope that all of you will you call for RRISD PD to take action to issue a trespass warning against this man. I am glad to see safety and security on the agenda for tomorrow, and I hope that you will use the information above in your safety and security discussions.

I also ask you to consider a full investigation to understand the inaction of RRISD PD to prevent this man from further harm and intimidation of women and community members, and to find out who made the decision that the video of the secondary incident was not of evidentiary value.

Good afternoon Mr. Black,

Firstly, thank you for coming to Round Rock ISD to monitor our Board of Trustees. As I'm sure you're aware, our district and its elected trustees are at the center of quite a few controversies and I'm optimistic that close guidance will help right the ship, so to speak.

Second, I have a question about the ethical guidelines as they related to elected Trustees' use of social media on their official candidate/official pages. Below you will see a screen shot from Dr. Jun Xiao's Trustee Facebook page in which he links a website, additional screen shots from that site are also linked. The website solicits donations for a political candidate for Texas Legislature, and Dr. Xiao appears to be supporting or endorsing this site. Is this an ethical violation, in your professional opinion.

To put it further into context, the person the runs that website is linked to an alleged assault on 10/21 and serious claims of online bullying/harassment of community members/trustee Bone/trustee Westin. The online harassment was so bad I had to file a police report and fear for my personal safety. These concerns have been reported to the board, superintendent and Chief Yarbrough but no action or investigation has been taken. Myself and Dustin Clark did an open records request for video of the alleged assault shortly after the encounter but we're just informed nearly twice months later that no video was available. We both reached out to the same group mentioned above asking for an explanation and again silence. Was it deleted? Are the cameras not operational? What are they hiding?

With all the being said, I'm requesting a censure of trustee Xiao, deleting of the fb post and a public apology that explains his violations of his code of ethics. I will be following up with a level 3 complaint with rrisd, tea and Texas ethics commission complaints as I'm confident trustee Xiao violated campaign finance laws as well.
