Hello.

My name is

I'm writing this email, because I'm concerned about the possibility of a mask mandate for RRISD schools. I think that the district should avoid a mask mandate(at least for high/middle school) and instead focus on encouraging masks and providing a virtual school option. Here is why:

- 1. The vast majority of high school & middle school students will already choose to wear a mask voluntarily. While a mask mandate may sway some to wear masks, it will also create a huge enforcement issue. I suspect that many students will be emboldened by the governor's order to defy the mask mandate. This is going to cause a huge headache for teachers/administrators that have to enforce mask wearing, especially when we still don't know if the mandates are legal.
- 2. Every single student and adult over the age of 12 has had access to a COVID Vaccine, and a third dose is being offered for those at risk. Kids are already at low risk. 4.2 million kids have tested positive for COVID, and only 0.008% of those have died. In fact, the 2018-2018 Flu Season was more deadly than COVID.
- 3. The University of Louisville conducted a study on the effectiveness of mask mandates. They concluded that mask mandates are "not associated with lower total cases or lower maximum growth rates" (Source: https://www.medrxiv.org/content/10.1101/2021.05.18.21257385v2)
- 4 Cloth and other non N95 masks can make the situation worse, as they accumulate moisture which promotes bacterial growth and other nasty stuff. This is especially true if they're not worn properly, reused without washing or worn for long periods of time. (which is a huge problem amongst kids of all ages), but can happen regardless. Several of my teachers told me that they had a fungal infection or bacterial growth on their face from prolonged mask use... despite washing the masks daily.

5. Some people have anxiety and other health issues surrounding prolonged mask usage. I personally have

6 The governor did issue an executive order against mask mandates in schools. We still don't know if the mask mandates are legal, and many kids will be emboldened to defy the mask mandates. How is the district supposed to deal with those kids when the governor says that they're right? Is this struggle really worth it if most students are wearing masks/vaccinated regardless.

Instead of a mask mandate, I propose

- 1) providing a virtual option for those who are concerned about the virus. If someone is at risk, they can stay home.
- 2) highly encouraging mask wearing via educational posters.
- 3) making sure that students who have been in suspected contact w/covid are encouraged/required to stay at home and don't have to worry about attendance.
- 4) providing optional dassrooms with masks required where possible(esp. in elementary school).
- 5) reducing class sized where possible and implementing contract tracing

In conclusion, I don't believe that a mask mandate is necessary. Students are not at risk, and will mostly opt to wear a mask regardless. It's not worth the potential legal and enforcement issues that this mandate could cause. Instead, we should focus on voluntary masking efforts, contact tracing and social distancing. I don't expect a response from you as I know dealing with this is likely most difficult for you. But I feel compelled to document the harm that our colleague, Trustee Vessa, continues to perpetuate including on social media. Yesterday (5/31/2021) she posted on her trustee FB page about Democrats and Republicans in the Texas legislature and the demise of HB 1468. There are now over 150 comments on that post from community members and Vessa herself going back and forth about partisan politics, a senate bill unrelated to public education, info about Dr Aziaez and Vessa's comments about RRISD possibly funding virtual learning despite HB 1468 failing by "eating the cost". She goes on about personally working with Dr Azaiez on this issue and others.

Previously I had sent her emails on 15 and 25 May 2021 making her aware of her concerning pattern of behavior but it doesn't appear anything has changed. My understanding was that she was on vacation this week and taking a break from board business and social media. But that does not appear to be the case.

I don't think she has broken any laws. And I value the First Amendment. I worry about her on-going, consistent pattern of behavior undermining our ability to work as a team. I worry about her continually inflaming the community. I worry about her undermining Dr Azaiez' ability to be successful in the event that the board reaches a contract agreement with him. I feel compelled to bring these concerns to you. I don't expect a response to this email. But I stand ready to assist you and our colleagues in either getting Vessa to voluntarily stop this behavior (unlikely) or to remove her as the VP and explore options that will allow her to continue her duties as an elected official, but with official boundaries/guardrails put in place to preserve the boards ability to carry out its duties.

Fellow elected Republicans in Williamson County and the City of Round Rock,

I write to you to inform you that our school district is under attack from individuals in pursuit of lawlessness. Trustee Mary Bone and I need reinforcements. We need your help.

No doubt you have read that Dallas ISD, Houston ISD and Austin ISD have decided to defy Gov Abbott's executive order GA-38 (dated 29 Jul 2021) which prohibits any government entity from imposing a mask requirement. As you know, executive orders have the force of law.

This morning at 9:30 AM, Mary and I received a notice that a RRISD board of trustees meeting has been called by board president, Amy Weir, for 5:30 PM on Monday, 16 August 2021. The email we received states the following as the reason for the meeting:

"Due to the conflicting mandates by the state and local governments and the TROs that are being fought in court right now we will need to have a meeting on COVID protocols."

We have no doubt that this meeting has been set to call for a vote to join those rogue school districts and impose a mask mandate in Round Rock ISD which sits in your city and county. I am not aware of any other time that our school district or city or county government has called a meeting to contemplate violating the law. Mary and I cannot properly address this alone. We need all hands on deck.

We need you and so do our students and community.

Interestingly, the posted agenda item for the meeting uses this vague wording "Fall 2021 Covid-19 Health and Safety Protocols." The item is posted such that the board is empowered to take action to vote on a mask mandate. I have attached a screenshot of the agenda to this email.

We need you to email the school board and superintendent (board of roundrockisd.org) and share your thoughts on this. We need you to alert the media. We need you to show up to the meeting and explain the importance of lawful governance to the trustees during public comments. We also need your help in preparing for how to move forward in the event that a majority (4 of 7) trustees vote to violate the law and unleash chaos in our city and county. The Travis County Judge and Austin Mayor have decided to fuel the chaos and have both issued their own mask mandates for schools. Nine of 55 RRISD campuses are in those jurisdictions. Those elected leaders have stepped forward to support the unlawful mask mandate put forward by AISD. Those elected officials are now on the field and fully participating.

What is at stake? The physical and mental health of our youth and the preservation of law and order. Our community deserves stability and predictability... Especially for our children. Parents need to know that our schools are places where the law and parental rights are respected. Now is not a time to blend in with the wallpaper and hope nobody notices. Now is the time to step forward and stand for what is right and to protect our children.

I spoke to Mayor Craig Morgan and County Judge Bill Gravell earlier today and shared all of this with them. Mary and I spend much of our time attending numerous Republican club meetings in the area. Everywhere we go citizens see what we are doing and they ask what they can do to help. People are

watching and paying attention to which of their elected leaders is doing the heavy lifting and leading. Mary and I are fearless and smart. We are also in the minority on the school board. We cannot do this by ourselves.

For reasons unknown to Mary and I, RRISD has declined to pursue the more prudent path that Leander ISD, Georgetown ISD's and Pflugerville ISD have chosen. All of those districts have wisely issued statements that they will be abiding by governor Abbott's executive order and that masks will be optional in their school districts. None of them have called for a meeting on the subject.

We are on the side of the law and the angels. We need your help to protect our children and our community from those who seek to sow chaos and lawless rebellion. We have no doubt that this meeting has been set to call for a vote to join those rogue school districts and impose a mask mandate in Round Rock ISD which sits in your city and county. I am not aware of any other time that our school district or city or county government has called a meeting to contemplate violating the law. Mary and I cannot properly address this alone. We need all hands on deck.

We need you and so do our students and community.

Interestingly, the posted agenda item for the meeting uses this vague wording "Fall 2021 Covid-19 Health and Safety Protocols." The item is posted such that the board is empowered to take action to vote on a mask mandate. I have attached a screenshot of the agenda to this email.

We need you to email the school board and superintendent (board of roundrockisd.org) and share your thoughts on this. We need you to alert the media. We need you to show up to the meeting and explain the importance of lawful governance to the trustees during public comments. We also need your help in preparing for how to move forward in the event that a majority (4 of 7) trustees vote to violate the law and unleash chaos in our city and county. The Travis County Judge and Austin Mayor have decided to fuel the chaos and have both issued their own mask mandates for schools. Nine of 55 RRISD campuses are in those jurisdictions. Those elected leaders have stepped forward to support the unlawful mask mandate put forward by AISD. Those elected officials are now on the field and fully participating.

What is at stake? The physical and mental health of our youth and the preservation of law and order. Our community deserves stability and predictability... Especially for our children. Parents need to know that our schools are places where the law and parental rights are respected. Now is not a time to blend in with the wallpaper and hope nobody notices. Now is the time to step forward and stand for what is right and to protect our children.

I spoke to Mayor Craig Morgan and County Judge Bill Gravell earlier today and shared all of this with them. Mary and I spend much of our time attending numerous Republican club meetings in the area. Everywhere we go citizens see what we are doing and they ask what they can do to help. People are watching and paying attention to which of their elected leaders is doing the heavy lifting and leading. Mary and I are fearless and smart. We are also in the minority on the school board. We cannot do this by ourselves.

For reasons unknown to Mary and I, RRISD has declined to pursue the more prudent path that Leander ISD, Georgetown ISD's and Pflugerville ISD have chosen. All of those districts have wisely issued statements that they will be abiding by governor Abbott's executive order and that masks will be optional in their school districts. None of them have called for a meeting on the subject.

We are on the side of the law and the angels. We need your help to protect our children and our community from those who seek to sow chaos and lawless rebellion.
